

TEMPLATE FOR THE SUBMISSION OF ANNUAL STATISTICS ON DATA RETAINED BY MEMBER STATES PURSUANT TO DIRECTIVE 2006/24/EC ON THE RETENTION OF ELECTRONIC COMMUNICATIONS DATA

v 22 January 2009

Article 10 of Directive 2006/24/EC requires Member States to submit to the Commission annual statistics on data retained pursuant to the Directive. Statistics should be collated on a national basis and cover a 12 month period. The statistics should contribute to the Commission's evaluation of the Directive as set out in Article 14. Statistics provided to the Commission for the purpose of Article 10 should not contain personal data.
